Eligibility for CE Credit

The examination is available by A) Online or B) Paper exam option, however you **MUST** purchase the Home Study Audio Course, Transcript, or the Course Manual. Members of study groups, classes or treatment centers who wish to listen together to the Audio Course **must** purchase individual copies of the Course Manual.

You may pay for the course examination either at the same time as the Home Study Audio Course or Course Manual or at a later time. There is an additional \$10.00 fee for manually scoring the paper exam.

Please be aware that the Home Study Audio Course, the Course Transcript and the Course Manual are protected by copyright and (except as noted on the RDI script and worksheet) may not be duplicated.

A passing score of 75% is needed to document course completion and receive credit. The form documenting your continuing education credits will be dated as of the date of passing the exam. You may retake the examination to obtain a passing score.

CE Examination Information

To obtain hours of continuing education for relicensure or EMDRIA™ credits you must pay for the exam. Before you pay for the exam, chose whether to take either the A) Online exam or B) Paper exam (for a \$10 additional manual scoring fee).

A) How to take the online exam. (This is the fastest and easiest way to submit your exam.)

1) Take the online exam at:

When you complete the online exam it will create a pre-addressed, encrypted email using your default email service. Just click "Email" and the "OK" button to send your results. If you do not pass the online exam, you may take it multiple times without additional charge.

2) Complete the course evaluation at:

(The link to the course evaluation page will remain open in the background when you finish and close the exam window.) The course evaluation will be automatically emailed to the office through a web form and a copy will be emailed to you.

3) Once we receive your email exam results confirming you passed the exam and the course evaluation, we will confirm you paid for the course. Then, you will be emailed a PDF version of your certificate of completion listing the credits you have earned.

B) How to take the paper exam.

1) Pay the optional \$10.00 fee for scoring a paper exam when you order. Download and print the PDF containing the answer sheet, evaluation form and affirmation page from:

3) Once we receive your completed answer sheet, evaluation form and affirmation page we will confirm you paid for the paper option and then score your exam. When you pass the exam, we will email you a PDF of your certificate of completion listing the credits earned. Please print the PDF for your records.

Note: those who purchased their examination packets and received them by mail before the December 28, 2009 price increase do not have to pay the optional \$10 paper exam fee.

If you do not pass the exam, we will email (or mail) you a list of the questions you missed. You may retake the exam to obtain a passing score. The first retake is without additional charge. For subsequent retakes, there is a \$10 fee.

12 continuing education credits for relicensure are available for listed mental health professionals.
